

HILTON GRAMMY'S SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Hilton GRAMMY'S Sweepstakes ("Sweepstakes") is sponsored by Hilton Domestic Operating Company, Inc. ("Sponsor"), 7930 Jones Branch Drive, Mclean, VA 22102 and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on January 26, 2020 at 8:00 PM Eastern Time ("ET") and ends on January 26, 2020 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

3. **HOW TO ENTER:** During the Sweepstakes Period, an eligible entrant must first sign into his/her Twitter account (entrant may create a Twitter account for free if he/she does not already have one) and become a follower of @HiltonHonors on Twitter (if not already following @HiltonHonors). - ii. First Prize Drawing: To enter a first prize drawing ("First Prize Drawing"), Retweet one (1) of Hilton's Tweets about a specific awards Category (see chart below)

and comment in the Retweet who entrant thinks will win for the Category specific to that Tweet (Artist of the Year, Record of the Year, Song of the Year, or Best New Artist of the Year) (entrant does **not** have to guess correctly in order to earn a Sweepstakes Entry) along with the hashtag “#HiltonSweepstakes”, to earn one (1) Entry into the applicable Category Pool. There are four (4) First Prize Drawing Pools, one (1) per Category.

The content included in the Entry will not be judged or used in any way to determine a winner. By entering the Sweepstakes and using the hashtag “#HiltonSweepstakes (for First Prize Drawings), entrant hereby agrees to be bound by these Official Rules. Entries will be deemed made by the authorized account holder of the Twitter account the Entry is submitted from at the time of entry. The “authorized account holder” is the person who is assigned to the Twitter account by the online service provider. An entrant must have a non-private Twitter account to enter the Sweepstakes and must be a follower of @HiltonHonors on Twitter until February 26, 2020 for potential winner notification purposes to be eligible to win/claim a prize. If an entrant does not have a non-private Twitter account, he/she can create one at no cost by visiting www.twitter.com. Further, entrant specifically agrees to release Twitter from any and all liability associated with this Sweepstakes. This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Twitter or any of its affiliates.

4. **RANDOM DRAWING:** On or around January 27, 2020, the Administrator will randomly select five (5) potential grand prize winners, one (1) from all eligible entries received for each Grand Prize Drawing Pool and four (4) potential first prize winners, one (1) from all eligible entries received for each First Prize Drawing Pool during the Sweepstakes Period. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.
5. **PRIZES, APPROXIMATE RETAIL VALUES ("ARV"), AND ODDS OF WINNING:**
 - A. **Grand Prizes (5 total; 1 per Grand Prize Drawing Pool):** Each grand prize is two (2) concert tickets to winner's choice of a musical artist (who is on a United States tour in 2020) from any Category (each a "Grand Prize"). Each Grand Prize includes round-trip coach class air transportation from a major commercial airport near winner's residence

to the winner's selected concert (in the United States only) for winner and one (1) guest (age eighteen [18] or older), two (2) nights hotel standard accommodations (single room/double occupancy) hotel based on concert location and determined by Sponsor in its sole discretion), a \$200 voucher for ground transportation (voucher determined by Sponsor in its sole discretion), and two (2) tickets to winner's choice of a musical artist from any Category. **Concert tickets based on availability. Specific concert, concert date and seat location determined by Sponsor in its sole discretion.** Winner's guests must be eighteen (18) years of age or older. If a winner elects to travel or partake in the Grand Prize without a guest, no additional compensation will be awarded to the winner. **Concert and hotel must be booked by December 31, 2020 and is subject to availability and blackout dates as determined by Sponsor in its sole discretion.** Winner must travel on dates determined by Sponsor in its sole discretion. Each winner and guest must travel on the same itinerary. The actual value of the trip may vary depending on point of departure and fluctuations in the cost of air transportation. Any difference between the estimated ARV and the actual value of the Grand Prize will not be awarded. If winner resides within a 100-mile radius of destination, ground transportation may be provided in lieu of air transportation, and no compensation will be provided for any difference in prize value. Sponsor is not responsible if event is delayed, postponed, or canceled for any reason. Winner will not receive compensation from Sponsor for tickets that the winner is unable to use due to cancellation of the event, but tickets may be subject to standard rain-check policies and procedures set by the issuer. Winner agrees that event admission is awarded pursuant to a revocable, nontransferable license that is personal to that applicable winner, and may not be sold, resold, auctioned, bartered, assigned, exchanged, placed in commerce, transferred, given away, donated or otherwise conveyed. Sponsor reserves the right to remove or to deny entry to winner and/or his/her guest if either winner or his/her guest violates the previous restrictions or engages in a disruptive manner, or with intent to abuse, threaten or harass any other person at the event. No more than five (5) Grand Prizes will be available in the Sweepstakes, one (1) per Grand Prize Drawing Pool. The ARV of each Grand Prize is \$5,000.

- B. First Prizes (4 total; 1 per First Prize Drawing Pool):** Each first prize is a two (2) night stay at winner's choice of a Hilton Hotel located in the United States (each a "First Prize"). Specific hotel and hotel location subject to availability and blackout dates as determined by Sponsor in its sole discretion. Hotel stay must be booked by December 31, 2020. No more than four (4) First Prizes (one [1] per First Prize Drawing Pool) will be

available in the Sweepstakes. The ARV of each First Prize is \$1,125. **Transportation not included as part of the First Prize.**

C. Total ARV: The total ARV of all prizes is \$29,500.

D. Odds of Winning: The odds of winning a Grand Prize or a First Prize depend on the number of eligible Sweepstakes Entries received for each Pool during the Sweepstakes Period.

E. General Conditions: There is a limit of one (1) prize per person. In no event will more than five (5) Grand Prizes and four (4) First Prizes be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received. The potential winners will be notified on Twitter by a Direct Message from @HiltonHonors with instructions on how to claim his/her prize. The potential winners must respond to the Twitter Direct Message winner notification within twenty four (24) hours or they may, at the Sponsor's sole discretion, be disqualified. Potential winners will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) business days from the date of attempted notification or the prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. Failure to provide all required information and a signature on the documents within the stated time period may result in forfeiture of winner's right to claim a prize, and may result in the prize being awarded to an alternate winner, if time permits. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be re-awarded. Upon verification of eligibility, each winner will be contacted to make arrangements for his/her prize. Prizes are not transferable and include only the items specifically listed as part of a prize. Any portion of a prize not accepted by winner will be forfeited. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for the prize won. Sponsor will issue an IRS Form 1099 for to each winner. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. The prizes will only be awarded to a verified winner.
